CURRICULUM

In 2011, National Farmers Union's education curriculum of "Growing Good Taste" was especially timely. The Obama administration and USDA placed renewed emphasis on promoting nutritional balance as a way to address the increasing health concerns (and waistlines) of Americans. Multiple lessons are available for youth in grades 1-2, 3-5, 6-8, and 9-12, along with separate lessons for collegiate and adult students. Advisors who visited the NFU booth at the National FFA convention were enthused to have this curriculum as a resource. Many volunteer youth leaders and state education directors participated in a webinar hosted by NFU that explores how the curriculum may be used.

BEGINNING FARMER INSTITUTE

Among the new educational programs being offered to members is National Farmers Union's Beginning Farmer Institute. Institute participants met for the first time in Washington, D.C., in September. Participants in the 2011 Institute include Erin Schneider of Wisconsin, Tess Brown-Lavoie of Rhode Island, Jeff and Deb Eschmeyer of Ohio, Aeric and Rex Reilly of Montana, Joseph and Ida DeFrancesco of Connecticut, and Barbara Marty and Justin Fehringer of Colorado.

The group includes cow-calf ranchers, row crop producers, CSA and farm market owners and an urban farmer. Institute participants gain a working knowledge of topics including USDA programs, risk management, bookkeeping and how to discuss a business plan with a lender, and lesser-known opportunities to generate farm income and keep production costs in line.

COLLEGIATE CONFERENCE ON COOPERATIVES

Thanks to the organizational efforts of Farmers Union and the CHS Foundation, Minneapolis has become a Mecca for college students and instructors interested in cooperative education. The annual College Conference on Cooperatives (CCOC) event draws 100 students from across the country. The students toured several local cooperatives, from CHS Inc., and REI to 7500 York Cooperative, the nation's first cooperative retirement complex. Presenters included members, directors, and managers from traditional and value-added agricultural cooperatives, as well as perspectives from electric, housing, and worker-owned co-ops. Students also heard from others involved in consumer cooperatives such as credit unions and food co-ops.



FARMER-TO-FARMER

Working through NFU's partnership with the National Cooperative Business Association, NFU Vice President Claudia Svarstad, New England Farmers Union (NEFU) President Annie Cheatham and Jessica Cook, NEFU member and farm energy program manager, traveled to the Republic of Senegal to work with the country's largest farm organization, assisting with advocacy, planning, membership, communication, and education. Kansas Farmers Union President Donn Teske also worked with Senegalese farmers on increasing their production and marketing through the program.

WOMEN'S CONFERENCE

After a hiatus of several years, the National Farmers Union Women's Conference has been retooled and will be held June 21-23, 2012, at NFU's education center in Colorado. Several trainings were held this year for the leaders of the conference. Thanks to support from the NFU Foundation, Farm Credit, CoBank, and the FUI Foundation, the three-day event will be both affordable and educational. The Annie's Project methodology is being used to develop the agenda.

Doug Peterson served in the Minnesota state legislature for twelve years before taking on the role of president of Minnesota Farmers Union. 

FINANCIALS

Source of Funds for Operational Expenses NFU/NFUSA 2002 - 2011



During the period from 2008 through 2011, operational expenses have varied for a number of reasons. Expenses peaked in 2008 due to the consolidation of the Denver office and the Washington, D.C., office, resulting in significant severance expense to Denver-based employees, shipping costs of equipment and records, and relocation administrative costs. Additional extraordinary expenses included start-up costs of the Carbon Credit Program and Wind Energy Project.

Expenses dropped significantly in 2009 and again in 2010 due to numerous staff vacancies following the consolidation of offices and efficiencies gained through a single office location. Several grants were secured by the NFU Foundation and NFU, which also offset significant staff salary expenses.

The increase in total estimated 2011 expenses includes completion of the first year of full staffing of the office since 2008, startup costs of the new California Farmers Union Insurance Agency, and reorganizational and membership development projects in several state divisions.
