 - NFU is a plaintiff in a lawsuit alleging that America's four largest beef packers conspired to suppress the price of cattle and increase the price of beef. Thomas Undlin is the lead attorney in the case and works on complex business disputes, including antitrust claims, in a wide range of jurisdictions. From his vantage point as litigator in this important case, Mr. Undlin has a unique perspective on how legal actions can help advance the goals of NFU's Fairness for Farmers campaign.
- Remarks from Kevin O'Reilly, U.S. PIRG

Right to Repair is an important part of NFU's Fairness for Farmers campaign and PIRG is a key ally. NFU and PIRG have partnered on numerous reports, surveys, and advocacy efforts aimed at exposing how equipment manufacturers are preventing farmers from fixing their own equipment, harming their bottom line, and reducing options for independent repair. Kevin O'Reilly is a leader in the Right to Repair movement and will share his perspective on the progress made so far and what it will take to win.

• 2023 Farm Bill Outlook

The current farm bill expires on September 30, 2023, and Congress will be considering, debating, amending, and adopting the next version of the wide-ranging agricultural legislation in the coming months. With so many interests and issues at stake — including farm production and risk management, conservation and climate, competition and resiliency, nutrition and food security, rural development and trade — the farm bill process will be complicated but important. Senior staff from the agriculture committees on Capitol Hill will provide insights and updates into the 2023 Farm Bill process to help Farmers Union members to be prepared for grassroots advocacy in the year ahead.
